Standards Interpretation Committee Questions and Answers

The Standards Interpretation Committee have published the proposed responses to questions raised by organic stakeholders for a comment period until September 17. Subjects include: GMOs in input, fertilizer and amendment substrates, livestock treatment, and food preparation. Ecocert Canada considers the answers to be coherent and will not issue any comments.

Presence of didecylidimethylammonium chloride (DDAC) residues in organic products

If you are exporting products to the European market, any detection of DDAC higher than 0.01 mg/kg will result in the automatic downgrading of a organic product to conventional. This chemical compound can be present in quaternary ammonium based cleaners such as *Agrilife*, *Biocit*, *Bioclean*, *Biolife*, *Citrex 100*, *Citrex Liquid I*, *Dipper*, *Lonlife 100*, *Preserve*, *VI-Care*, and *Procidic*. Please check if DDAC is present in the cleaning products you use. If so, please confirm with us that your cleaning procedures prevent all possible contamination of food.

TOOLBOX

The Consumer Packaging and Labelling Act applies to non-certified "organic" products

There are no intraprovincial organic regulations in the majority of Canadian provinces but the Canadian Food Inspection Agency is responsible for the administration of the Consumer Packaging and Labelling Act which applies to food and feed. The OFC and the Canada Organic Office are currently discussing how CFIA inspectors are trained to conduct an audit when a retailer, trader or producer is accused of falsely adding the "organic" designation to a non certified product that does not seem to comply with the organic standard. Updating your file...

The CFIA, the CARTV and the USDA monitor the marketing of organic products within their respective territories. To avoid fines and product recalls, you must inform us of any changes to your production/preparation plan when adding new products or modifying recipes, ingredients or labels. Products that do not appear on your certificate cannot be marketed as organic.

The study of your file

Following inspection, certificates are issued only following payment. There are different payment options available to avoid any delays the issuance of your certificate (pre-authorized withdrawals, AccessD, post-dated cheques). Organic Hay

Due to high temperatures and little rain this summer in many regions of Quebec and Ontario, there's a lack of organic hay for livestock feed. If you happen to foresee an organic hay surplus on your farm, please inform us by email at office.canada@ecocert.com. We will maintain a list of organic hay supplies to help out the farmers who need it.

Reminder: Certificate expiration date

This is a friendly reminder that Ecocert organic certificates no longer include an expiration date. According to the Canada Organic Office Operating Manual, the certification of your products is continuously valid until certification is either abandoned or revoked. This means that your current certificate is valid until it is replaced by the new certificate following your annual inspection. We no longer issue certificate prolongations.

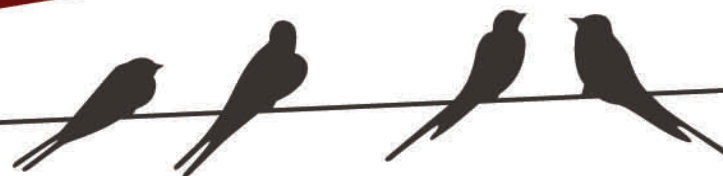
REGULATIONS

Europe

Clients who are exporting non-100% Canadian products to the European market must label these products according to the origin of the ingredients following changes to the European Regulations on the importation of organic products as of June 2012. If you wish to explore the European market please contact us before your first shipment to make sure you are well informed on requirements.

As of January 2012, China requires all important organic products be certified according to the Chinese Organic Standards. Group Ecocert holds the necessary accreditation in China. Contact us if you intend to export to this market.
